The debtor(s), through counsel, respectfully makes the following motion and moves the Court for an Order:

- (1) The debtor(s) has a confirmed Chapter 13 plan or confirmation is pending.
- (2) The debtor(s) owns property as described in 11 U.S.C. Section 522(f)(1)(B) consisting of:
 - [] (i) household furnishings, household goods, wearing apparel, appliances, books, animals, crops, musical instruments, or jewelry that are held primarily for the personal, family or household use of the debtor or a dependent of the debtor;
 - [] (ii) implements, professional books or tools of the trade of the debtor or the trade of a dependent of the debtor; or
 - [] (iii) professionally prescribed health aids for the debtor or a dependent of the debtor.
- (3) The total value of the property is _____ which is less than the amount allowed as exempt by N.C.G.S. 1C-1601(a).
- (4) A nonpossessory, nonpurchase-money security interest in this property may be claimed by the following: (name and address) _____
- (5) Any non-possessory, non-purchase money liens claimed by the above-named claimant impair the exemption to which the debtor(s) is entitled pursuant to 11 U.S.C. Section 522 and N.C.G.S. 1C-1601(a).

WHEREFORE, the movant prays that the Court enter an Order finding:

- (1) The debtor(s) own certain property as described herein and the value of the debtor(s) property is no greater than the amount of exemption to which the debtor(s) is entitled to claim under N.C.G.S. 1C-1601(a).
- (2) The lien held by the above-referenced claimant is a nonpossessory, nonpurchase-money security interest impairing exemptions to which the debtor(s) is entitled.
- (3) The nonpossessory, nonpurchase-money security interest held by the above-named claimant is avoided pursuant to 11 U.S.C. Section 522(f)(1)(B).

The movant further recommends that notice of this motion and any orders pursuant thereto be sent to the parties named on the attached service list.
