1. The Trustee filed his Motion on August 14, 2014.
2. Proper notice of the Trustee's Motion was given to parties in interest and no responses were filed with the Court by the bar date of February 22, 2015.
3. There has come into the control of the Trustee assets consisting of a 1994 Lexus ES300 and a 2000 Sun Line Polaris Camper.
4. There are no liens of record on the property.
