THE CALENDARS ARE ARRANGED IN ALPHABETICAL ORDER BY THE ATTORNEY'S LAST NAME. AN 'A' OR 'E' OR 'I' OR 'M' OR 'R' WILL APPEAR ON THE RIGHT CORNER OF THE CALENDAR. 'A' CALENDARS ARE CALLED ALPHABETICALLY; 'E' CALENDARS ARE CALLED E-Z AND THEN A-D; 'I' CALENDARS ARE CALLED I-Z AND THEN A-H; 'M' CALENDARS ARE CALLED M-Z AND THEN A-L; 'R' CALENDARS ARE CALLED R-Z AND THEN A-Q.
