'A' CALENDARS ARE CALLED ALPHABETICALLY; 'E' CALENDARS ARE CALLED E-Z AND THEN A-D; 'I' CALENDARS ARE CALLED I-Z AND THEN A-H; 'M' CALENDARS ARE CALLED M-Z AND THEN A-L; 'R' CALENDARS ARE CALLED R-Z AND THEN A-Q.
