"A" CALENDARS ARE CALLED ALPHABETICALLY; "E" CALENDARS ARE CALLED E-Z AND THEN A-D; "T" CALENDARS ARE CALLED I-Z AND THEN A-H; "M" CALENDARS ARE CALLED M-Z AND THEN A-L; "R" CALENDARS ARE CALLED R-Z AND THEN A-Q.
