NOTICE IS HEREBY GIVEN with respect to the property described as follows:

The Seller requests that (i) any successful bid competing with this Agreement must exceed the Buyer's commitments by at least \$5,000.00, and that (ii) any competing offeror must deposit with the Trustee a \$10,000.00 deposit at least seven days before the earlier of the date for hearing on approval of this Agreement or the deadline for objections to the proposed sale, and that (iii) any competing offeror must commit to substantially all other terms and provisions set forth in this Agreement, and that (iv) the Court allow any further competitive bidding by Buyer and any competing offerors who satisfy these requirements to be undertaken on the date of the hearing on this Agreement, by telephone or otherwise, or such other time as may be set by the Court with subsequent bidding to continue in increments of \$2,500.00.

The Trustee received an overbid of \$5,000.00 increasing the purchase price to \$155,000; and the Trustee is in the process of scheduling further competitive bidding by Buyer under the Agreement and the over bidder and any competing offerors who satisfy those requirements to be undertaken on April 10, 2019 with subsequent bidding to continue in increments of \$2,500.00.

Hearing upon the Motion was held on April 3, 2019 with further hearing continued and to be held on April 18, 2019.
