NOTICE OF EXTENDED INITIAL BIDDING DEADLINE FOR PUBLIC SALE OF
PROPERTY

NOW COMES, James B. Angell, Chapter 7 Trustee for Organic Transit, Inc., and gives notice that the deadline for the initial bidding for the sale of substantially all of the Debtor's assets is hereby extended to May 15, 2020, and shows the Court as follows:

1. On June 13, 2019, the above captioned Debtor filed a Petition under Chapter 7 of the Bankruptcy Code. James B. Angell was duly appointed as and serves as Trustee in this case.

2. On March 3, 2020, the Bankruptcy Court approved a procedure for the sale of substantially all of the Debtor's assets (Doc 69). The procedure provides for an initial bidding period and a second round of bidding.

3. The Order provides the Trustee may extend the deadlines without a court order.

4. The Trustee previously extended the deadline for the end of initial bidding initial from March 9, 2020 to March 31, 2020 to accommodate the requests of prospective buyers for additional time to compile a bid. Due to the COVID-19 virus and its effects on communications and the economy, requests from prospective purchasers for additional time past March 31, 2020 have been made.

5. Based on the recommendations of Carolina Financial Securities, LLC, which serves as broker for the Trustee, the Trustee is extending the end of the initial bid period to May 15, 2020. Due to the length of the extension, the Trustee provides this notice to the Court and to parties in interest.
